This is an agreement by and between Metroport Chamber ("VENDEE") and VENDOR listed below (Vendor") for VENDOR to arrive and distribute food/ beverage at The Taste ("EVENT"). The undersigned VENDOR agrees to following terms that are presented below.

VENDOR agrees to appear at the EVENT located at the Lucky Spur Ranch Retreat; 1780 Strader Rd. Justin, TX 76247 ("LOCATION") on **September 29, 2026** to share their food/beverages to those that are in attendance.

VENDOR agrees to provide food/beverage for those that are in attendance. 250+ attendees expected. The VENDEE agrees to waive the table fee in return for this service. VENDOR can bring additional attendees to assist with serving those in attendance at the EVENT.

VENDOR agrees to appear at LOCATION set to up between **1:00 PM - 4:00 PM and ready to serve at 5:30 PM**. If VENDOR may be late, they must notify a member of the VENDEE staff as soon as possible. Contact numbers will be provided. VENDOR can start to take down and clean up their station **no earlier than 8:30 PM and must vacate by 10:00 PM**. VENDEE will evaluate and advise if this time should change.

VENDOR acknowledges that display space is **located indoors** and agrees to **use electric equipment is limited so Sterno is preferred method to keep food warm. Other than Sterno, open flame is NOT allowed** at the Lucky Spur Ranch Retreat event venue. The entire Lucky Spur Ranch campus is also a smoke, vape, and tobacco-free venue except outdoors, and all attendees must be 18 years of age and older. **VENDOR agrees to provide a certificate of insurance per the attached terms and conditions. Please email to: metroportevents@metroportchamber.org**

VENDOR agrees that VENDEE is not responsible for any loss, stolen, or misplaced products at the EVENT. VENDOR has complete and sole responsibility for their products.

VENDOR agrees that the participation fee is waived as long as the food/beverage samples are provided to approximately (250) EVENT attendees.

VENDEE must purchase alcohol through the event venue unless otherwise authorized by the venue. Outside alcohol is not permitted without venue approval. VENDEE will provide VENDOR with two (2) tables.

VENDOR shall bring all linens and table displays. Display area is approximately 10'x10'. VENDEE does not guarantee sale of products and are not obligated to ensure that VENDOR recoups costs through sale of products or services.

VENDOR agrees that this shall be a binding contract, and all terms have been included here. Any modifications made to this contract must be in writing and signed by both parties in order to be enforceable. VENDOR acknowledges that VENDEE may not accept every Application and will finalize Applications based on availability and variety of types of food.

INSURANCE REQUIREMENTS



A

Licensee, at its expense, agrees to procure and maintain during the Term the following insurance coverages on an occurrence basis only: (i) a policy of commercial general liability insurance in an amount of not less than one million dollars (\$1,000,000) per occurrence and two million dollars (\$2,000,000) in the general aggregate each year, against claims for bodily injury, death and property damage occurring in connection with Licensee's use of the Space; (ii) workers' compensation insurance as required by statute and employers' liability insurance of at least one million dollars (\$1,000,000) per accident or disease; and (iii) comprehensive automobile liability insurance including coverage for owned, hired, and non-owned automobile liability, with combined single limits of not less than one million dollars (\$1,000,000) per occurrence.

B

If Metroport Chamber and Lucky Spur Ranch Retreat approves the serving of alcoholic beverages at the Space, Licensee shall provide evidence of liquor liability insurance coverage in the amount of at least one million dollars (\$1,000,000) per occurrence and in the aggregate.

C

Licensee must provide the Metroport Chamber and Lucky Spur Ranch Retreat with standard form certificates evidencing this insurance coverage no later than ten (10) days prior to the first day of the Term. The certificate(s) and policies shall further provide that: (i) Lucky Spur Ranch Retreat, any Landlord, any lender of any Landlord, any manager of the building which includes the Space (the "Building") and their respective parents, subsidiaries and affiliates are additional insureds under Licensee's liability coverages; and (ii) that Licensee's general liability policies shall be primary over any other valid and collectible insurance available to the additional insureds listed above. Licensee shall cause the carriers issuing such policies to waive all rights of subrogation against the additional insureds. The carrying of any of said insurance shall not be interpreted as relieving Licensee from any obligation under this License.

D

Any vendors or other third parties hired by Licensee to perform services at the Space shall be required to carry and to provide the Metroport Chamber and Lucky Spur Ranch Retreat with evidence of the same insurance coverages required of Licensee with the same entities named as additional insureds.
